ASSEMBLY REPORTS

Member Loon reported that on August 2, 2021, she attended the Incident Command meeting and due to the current rise of cases another Incident Command Meeting will be held soon. On August 5-6, 2021, she also attended the Alaska Municipal League Summer Legislative Session.

Member Armstrong reported that he attended the Alaska Municipal League (AML) Summer Legislative Session Conference also. He attended the Sulainich Meeting on August 12 and the Joint Construction and Maintenance Committee meeting on August 23.

Member Shroyer reminded everyone that all the ordinance and resolutions were discussed in detail at the BAF Work Session meeting which held on August 23, 2021.

Member Sampson commented that he also attended the AML Summer Legislative Conference and the AML Board of Director's meeting. He also attended the Joint Construction and Maintenance Committee also on August 23, 2021.

Member Swan reported they are moving forward with relocation discussions. The City of Kivalina, Kivalina IRA and CRW are planning to meet with the community to discuss relocation.

President Hadley reported that he also attended the AML Summer Legislative Conference held in Fairbanks, AK. He and Mayor Nelson sat on a panel in front of the Department of Defense, and he thought that the panel did a good job for Cape Blossom and for future development.

MAYORS REPORT

Mayor Nelson reported that her administration continues to have Staff and Director's meetings virtually and in person. They continue to provide ongoing updates to the Borough website in regard to borough events, meetings, and activities on the Borough's Facebook page. She added that they continue to hold Director's meetings as needed and in preparation for the North Slope Borough (NSB) & Northwest Arctic Borough (NAB) Joint

Meeting and Assembly BAF Work Session and Assembly Regular Meeting to be held August 23-25, 2021. Mayor Nelson reported that the Joint NSB and NAB Assembly meeting has been postponed until further notice due to the increase of cases in the region to September 22-23, 2021. She reported they will have another meeting in the future to discuss if this meeting will happen and look at the cases that are happening. Mayor Nelson reported that she had undergone major knee replacement surgery and was on medical leave August 6-20, 2021. Mayor Nelson reported that she will be taking additional leave until she gets a doctor's release after her next appointment which is the 25th.

Mayor Nelson reported on the Human Resources (HR) department and provided a brief update of new hires, transfers, job vacancies and promotions. Ms. Jaime Schaeffer has resigned VIF Coordinator position and the positions currently advertising are the Village Public Safety Officer, On Call Search & Rescue Coordinator, Planning Coordinator and VIF Administrator.

Mayor Nelson gave a Grant Writer update and grants applied for and waiting for results is the COVID-safe Travel Grant Program and the COVID Energy Response. Mayor Nelson reported that they did receive 50% of the American Rescue Plan and is working on a spend down plan of \$720,000.

Mayor Nelson reported that the Incident Command System (ICS) team and the Unified Command team hold meetings as needed. The Disaster Declaration was reinstated for ratification and Emergency Order 06 was established due to a rise in cases and it expires September 30, 2021.

Mayor Nelson reported she met with Jen Jarvis & Associates on July 28, 2021, regarding the Strategic Planning session that was held and next steps regarding priorities, leadership retreat, due diligence, future work session and launch the goals and objectives results from the July Assembly Retreat. Mayor reported that she also met with the Northwest Arctic Borough School District Youth leaders on July 29, 2021, to provide an update on Borough operations. She was happy to see so many students interested in youth leadership.

Mayor Nelson reported that she attended the Kivalina Relocation Meeting held by CRW. She attended the COVID 19 taskforce meeting on August 2, 2021, to inform the taskforces about current cases and what the plan was for reinstatement of declaration and emergency orders and regulations.

Mayor Nelson attended the Alaska Municipal League Summer Legislative Conference in Fairbanks, AK on August 4-6, 2021, but more specific for the Alaska Conference of

Mayor's (ACOM) conference. The major discussions were related to legislative session happenings in Juneau. She reported that the ACOM group came together and decided that a letter of recommendation would be provided to the legislative group in Juneau about a recommendation on how to solve the FY22 Budget. Mayor Nelson commented that she was also on the panel as Mr. President Hadley stated, to speak about Arctic Infrastructure to the Department of Defense mainly in regard to two transportation needs which are the Cape Blossom Road and Port: also, community and resource development needs both for Kotzebue and each community village.

Mayor Nelson also attended the Northwest Arctic Borough/North Slope Borough (NAB/NSB) Work Session on August 16, 2021, to discuss agenda topics and Covid case status to determine if a future meeting will stand or be rescheduled. Lastly, Mayor Nelson reviewed future meetings for September as stated in her report in the packet.

TIME & PLACE OF NEXT MEETING

Mayor Nelson recommended a NAB Budget Retreat on Monday, September 27, 2021 at 9:00 am – 4:30 pm. Continue on Tuesday, September 28, 2021 at 9:00 am – 12:00 pm. A BAF Work session to be held at the Assembly Chambers on Tuesday, September 28, 2021 at 1:00 pm and the Regular Meeting on Wednesday, September 29, 2021 at 9:00 am.

By unanimous consent of the Assembly the next meeting dates of September 27-29, 2021 were recommended, as set in code.

Member Cleveland thanked everyone for a good meeting and that a lot of good information was shared today. He reported that on August 6, 2021, their tribal council was changed, and they are moving forward. He gave his condolences who lost their loved ones also.

Member Ballot commented that we had a really good meeting today and she thanked the Assembly on behalf of the community of Selawik for approving their water and sewer evaluation project as they will be conducting a thorough assessment. She encouraged the communities to turn in their VIF applications so their way of life can be improved with projects approved. Member Ballot gave her sincere condolences to the families who have lost their loved ones. She addressed the importance of working on public safety in our region and she encouraged the youth to get trained in this area of public safety as it is good to have our own home-grown people to work in these positions. She thanked Mayor Nelson and her staff for all the work they do, and she encouraged everyone to practice safety measures.

Youth Representative Ms. Tahayla Baker commented that it is a rude awakening to see that the COVID numbers are rising even though we got vaccinated and the importance of keeping up with the precautions. She congratulated the students who are attending college for the first time and a big congratulations to Ms. Marjorie Baker for her first year of teaching 1st grade at the JNES School.

Vice President member Sampson thanked the Assembly for good discussion and update on the COVID pandemic as we see that the numbers are rising when we thought they were going down. He encouraged everyone in the villages to get vaccinated and he

Lastly, she gave her condolences to those who have their loved ones.
