These options are intended to encourage growth of locally owned and operated commercial fishermen, provide additional employment and income in the region, and promote safety through the Coast Guard requirements.

- You must provide a current commercial fishing Permit.
- Payments will be directly paid to the Vendor.
- The resale of any fishing equipment obtained by this grant is absolutely prohibited.
- The budget is \$1500.00. If over the budget, the applicant will pay the remaining balance.
- This Grant is a first come first serve basis.

Grants are available for payments to suppliers of the following items and services:

- Nets, equipment, and/or Coast Guard required items for commercial fishing.
- Invoices from vendors/suppliers for grant request amount.
