Member Magdanz reported that he participated in the Joint Construction and Maintenance Committee (JCMC) and they heard updates on the JNES Roof Replacement, Buckland HVAC project, next steps for the Deering School and the ATC family housing.

Member Swan reported that he attended a meeting in Kivalina regarding the landfill in preparation for a cleanup and then selecting a new landfill site.

President Armstrong reported that he attended the AML Winter Conference Legislative Session and they heard from various Directors from Governor Dunleavy's administration. They also heard a report from the Alaska State Troopers and that it was a good conference.

President Hadley reported that he also attended the AML Winter Conference where they received a lot of good information and moving forward with the Governor's budget. They had lunch meeting with the Borough's consultant Ms. Wendy Chamberlain. Ms. Tessa Baldwin met with Department of Public Safety Commissioner, and they shared the VPSO regulations and potential changes that is going to benefit our region. They also attended a Senate Hearing pm SB81 regarding the VPSO Program.
