<u>CANDIDATE NOMINATIONS</u>: Please contact the Borough Clerk for nominating petitions. Petitions will be accepted between Monday, June 6, 2022, until Monday, August 22, 2022.

<u>VOTER QUALIFICATIONS</u>: "Voter" means a United States citizen who is qualified to vote in state elections and has been a resident of the Borough for at least 30 days preceding the election and is registered to vote in state elections and is not otherwise disqualified.

\*Campaigning is prohibited within 200 feet of any entrance to the polling place. (AS 15.15.170)\*
