ORDINANCE 16-01**

**AN ORDINANCE OF THE NORTHWEST ARCTIC BOROUGH  
ASSEMBLY APPROVING A CONTRACT AMENDMENT WITH  
BERING STRAITS, AND FOR RELATED PURPOSES.**

**WHEREAS:** the Borough received a multi-year Coastal Impact Assistance Program (CIAP) energy conservation grant that in part, provides the Borough funding to purchase and install Solar-PV array panels in selected Borough communities; and

**WHEREAS:** use of the Solar-PV array panels will help reduce the cost of power while providing an alternative energy source; and


**WHEREAS:** as part of the grant, the Borough Assembly previously approved contracts and respective amendments through Resolutions 11-38, 14-02, and 15-46 to use Bering Straits as a contractor to install the Solar-PV arrays; and

**WHEREAS:** the Borough wishes to extend the completion deadline through March 30, 2016 under an amendment to its Professional Services Agreement with Bering Straits Development Company.


**NOW THEREFORE BE IT ENACTED:** by the Northwest Arctic Borough Assembly, for and on behalf of the Northwest Arctic Borough that:

1. Except as otherwise explicitly agreed to in Agreement Amendment Four, all terms and conditions as set forth in the parties Professional Services Agreement, FY14-29 originally approved by NAB Resolution 14-02 (the "Agreement") shall remain the same.
2. Exhibit A, Schedule, is amended to require that the work to be performed under the Agreement shall be completed no later than March 30, 2016.
3. This resolution shall be effective upon enactment.



**PROFESSIONAL SERVICES AGREEMENT AMENDMENT FOUR**  
**Contract Number FY14-29**

THIS AMENDMENT FOUR TO PROFESSIONAL SERVICES AGREEMENT FY14-29 ("Amendment Four") is effective as of November 30, 2015, between the NORTHWEST ARCTIC BOROUGH ("NAB"), an Alaska Municipal corporation, whose address is P.O.
