She read the public notice for the vacancy of District 4 Seat J formally held by Member Reggie Joule.

Member Loon requested that the Election committee meet before the next election. She thanked NANA for providing rides for the Elders to come to the polls and added that if we provided rides for the disabled and elders, the percentage of voter turnout will be higher.
