REORGANIZATION

Mr. Matt Mead, Borough Attorney, explained the practice of nominating and voting for a Chair and Vice Chair of the Assembly.

Member Carr nominated Member Hadley for President; Member Sampson motioned to close the nominations, Member Shroyer Beaver seconded to close the nominations. Member Hadley is reelected as the President of the Northwest Arctic Borough Assembly.

Mr. Mead opened the floor for Vice President. Member Armstrong nominated Member Sampson; Member Shroyer Beaver nominated Member Carr. Member Swan motioned to close the nominations, Member Ballot seconded to close the nominations.

Mr. Mead directed the clerks to pass out paper for voting and to expect text messages from members who will voting via their phone.

President Hadley reminded everyone of the Borough mandate that is in place to have up to ten people in the room at a time so the Borough have been holding telephonic meetings only.

Borough Clerk Helena Hildreth reported the results for Vice President. Member Sampson received six votes and Member Carr received five votes. President Hadley congratulated Member Sampson as the incoming Vice President of the Assembly.

APPROVAL OF PREVIOUS MEETING MINUTES

Regular meeting minutes of September 22, 2020 and Special meeting minutes of October 12, 2020, as presented.

Member Sampson motioned to approve the September 22, 2020 Regular minutes as presented, *Member Cleveland* seconded; a roll call was conducted and the motion passed unanimously.

COMMUNICATIONS AND APPEARANCES

Tony Giardini, and Elaine Sanders, Trilogy Metals

Mr. Tony Giardini, Trilogy Metals, gave an update on a brief summary of the legal action against the Ambler Road Project. He added that a second lawsuit was on behalf of the coalition of Alaska Native American Tribes and Alaska Native Corporations (ANC), including the Kobuk Traditional Council. Mr. Giardini gave a brief review of the specifics of the lawsuit. They are presently working directly with AIDEA (Alaska Industrial Development Export Authority) to reach a memorandum of understanding or funding

agreement on the first phase of the development of the Ambler Road Project, which involves detailed engineering. They are engaged with AIDEA on a tolling arrangement associated with the industrial road and they will be meeting in November to approve a budget for the 2021 field season.

Member Sampson asked what the delay may cause and Mr. Giardini commented they anticipate that both of the law suits will be combined and that the field season schedule will not be impacted. Member Nay asked what other tribal entities or ANC's are involved in the lawsuit and Mr. Giardini highlighted the plaintiffs. Member Sandy Shroyer commended the Kobuk Traditional Council for their efforts if this is what they choose to do and she added that they should hire everyone who is qualified to work. Member Loon commented about the close tithes the Upper Kobuk people have with other closer villages such as Huslia, Allakaket, etc. and their concerns for each other. Member Carr thanked Mr. Giardini for his presentation and recommended that he get with the local entities here and utilize our Alaska Technical Center for training our people and practice good measures for local hire. Member Cleveland commented that the decisions we make today will affect our children and grandchildren. Member Nay asked what plans does Ambler Metals have in terms of outreach with councils and communities and Mr. Giardini replied that there will be significant outreach to the communities and the team is based in Alaska with an office in Anchorage, AK. Member Sampson recommended that our legal counsel review the lawsuit case and from there take a look at the impacts to our government. Mr. Mead commented that he would be happy to provide updates to the assembly regarding the lawsuit. Member Ballot asked if there has been any studies to the impact on our subsistence resources. Mr. Giardini commented that they will forward the documentation from environmental impact studies that was completed. Member Cleveland thanked Trilogy for employing people from their area as they are feeling the impact of the closure this year.

2. Joe DolleMolle, District Ranger for the National Park Service

Mr. DolleMolle gave an introduction of himself and his duties as a District Ranger within the National Park Service for the Northwest Arctic. He provided an update of who is eligible to hunt in the parks within the Northwest Arctic Borough.

A ten minute break was taken at 10:55 am. The meeting reconvened from break at 11:12 am.

President Hadley added that the Assembly reviewed the letters of interest for vacant seat District 4 Seat J. The Assembly voted for Ms. Elia Nay, Kotzebue resident, to fill in the vacancy until 10/21. Ms. Nay provided a brief introduction of herself and is happy to be onboard with the Assembly.

Ms. Angle Sturm, Borough Treasurer, provided a summary of Expenditures and Revenue Financials in month ending September 30, 2020.

Mayor Nelson summarized Ordinance 20-08, recommending approval.

Member Sampson motioned to approve Ordinance 20-08 for enactment, seconded by Member Shroyer Beaver. A roll call was conducted and the motion passed by a majority with Member Carr voting NO.

 Ordinance 20-09 an ordinance of the Northwest Arctic Borough Assembly amending the Borough Revenue and Finance Code.

Mayor Nelson summarized Ordinance 20-09, recommending approval.

Member Carr motioned to approve Ordinance 20-09 for enactment, seconded by Member Sampson. A roll call was conducted and the motion passed unanimously.

ASSEMBLY REPORTS

Member Carr reported that she and President Hadley have been attending the weekly COVID19 taskforce. She reminded everyone that the City supersedes the Borough's mandates but the villages can exercise tighter restraints. She also commented that she attended the Planning Commission meeting and they also heard Mr. Joe Dollemolle's presentation.

Member Swan provided a brief update on the Kivalina Evacuation Road and that was why he was absent for a bit from the meeting as he was participated in the inspection of the road. It is one of the better roads that was built because of the type of material source and they plan to conduct an official ceremony next summer after some more work is done on the bridge.

MAYORS REPORT

Mayor Nelson reported that they held a staff meeting to discuss the changes to the COVID19 policy and they also held a Director's meeting to review changes that affect daily operations. She also has been working on the annual report and that they are close to finalizing the draft report. She welcomed new hires, Jerrin McConnell, Maintenance Technician; Clay Nordlum, Planning Coordinator; and Eva Harvey, Planning Director. Mayor Nelson reported she continues to attend the Incident Command meetings and extended the Hunker down Response Order to protect all residents that will expire in two weeks. She continues to attend the Unified Command meetings on a weekly basis and they review cases that are rising and/or other issues from residents or organizations. She attended the Northwest Arctic Leadership Team (NWALT) meeting and met with Ms. Alyse Galvin, Congressional Delegate candidate, to listen to her campaign platform. She attended the Arctic Mining District Negotiating Committee (AMDNC) at the end of September to discuss opportunities such as the permitting process, rights of way research, etc. Lastly, she attended the Community and Economic Development regarding the Economic relief program to discuss options of relief package and roll out of applications on the website which was open on October 19. Mayor Nelson also attended the Energy Steering Committee via Zoom and discussed energy data and project updates. and the Independent Power Producers (IPP).

Member Armstrong thanked Mayor Nelson for the CARES Act Relief funds for the residents and also asked what the balance was and Mayor Nelson provided an update on what was received from the CARES Act Relief funds and the current balance. Member Armstrong also requested on the status of the reporting for the VIC project funds. Mr. Kotch, Public Services Director, provided a brief update on the VIF reporting received from the village project awards.

Mayor Nelson recommended November 23-24, 2020 as the 4th Monday and Tuesday of the month for the next Regular meeting of the Assembly.

He requested that we continue to support development in our region as the Red Dog Mine won't be here too much longer to help support our communities.

Member Armstrong thanked everyone for a good meeting and the presenters for the information they provided. He welcomed the new members on the Assembly and is
