2.04.040 Compensation and per diem of assembly members.

D. On or after July 1st of each year, the assembly shall appoint two youth representatives on the assembly as advisory seats. The two youth representatives shall be nonvoting members whose primary role shall include providing recommendations and support to assembly members. The mayor may nominate one or more youth for the assembly to consider for the two appointments on an annual basis with a term ending June 30th of each calendar year. No youth representative may serve more than a single one-year term. The position shall be open to all Northwest Arctic Borough residents between the ages of 16 and 21 years of age. Nominations shall be made by submission of letters of interest to the mayor. The rate of compensation shall be \$150.00 per meeting attended. In addition, the youth representative shall receive per diem for each day or part of a day the representative is away from his/her village of residence to attend a meeting of the assembly. The per diem rate shall be the same as that set in subsection (B) of this section.
