This grant opportunity offers financial assistance options for new applicants. These options are intended to encourage growth of locally owned and operated businesses, provide additional employment and income in the region, and promote ideas and overall spirit of independent enterprise.

No grants will be payable directly to a grantee. This grant is for first time small business applicants and returning applicants.

Grants are available for payments to suppliers of the following items and services:

- Business supplies,
- Construction, repair, or renovation of business facilities,
- Cost of training and licensing,
- Other start-up costs

PLEASE NOTE: This grant cannot be used to purchase inventory or merchandise for resale.
