
**Amended COVID-19 Emergency Order NO. 33**


**March 24, 2022**


- ❖ Anyone entering Buckland by Land, Sea or Air **MUST** quarantine for five (5) days with a negative received within seventy-two (72) hours, all individuals/residents traveling into Buckland **MUST** coordinate their quarantine with Task Force Coordinator further known as T.F.C throughout this mandate. All travelers must wear a mask and social distance from others in the village.
- ❖ Day trip travelers and Red Dog workers are exempt from quarantine.
- ❖ Those who have a PHN letter and are in the Ninety (90) day period are exempt from quarantine.
- ❖ Residents must quarantine at a household or living quarters, for quarantine to be effective the individual or group must isolate at-large from the community, if a home is in quarantine together as a unit/family they may engage in outdoor activities, such as hunting, fishing ETC, they must keep social distance from other household families.
- ❖ Anyone with health problems or any pregnant ladies are allowed to take walks for daily exercises.
- ❖ Essential workers are allowed to go to their work site and return home after work, while at work they must wear a mask, gloves and any other protective gear. They must social distance from the village residents as much as possible, they are allowed into the store, post and fuel as long as they show a negative test taken within seventy-two (72) hours. Exemptions will be made on a case by case basis as per CDC guidelines. Students who are in quarantine are allowed to go to school and attend all school activities and must remain in quarantine afterwards. Students who are close contact or have a positive in the home are **NOT** allowed to attend school or school activities.
- ❖ Anyone who tested positive for Covid-19 must isolate for seven (7) days regardless of receiving a PHN letter. If a positive case is discovered in a household, those with PHN letters within the 90-day period to the new case are exempt from isolation/quarantine.
- ❖ Anyone who is a known close contact must isolate/quarantine five (5) days with a negative test on the fifth (5th) day and watch for any symptoms headache, fever, cough, vomiting ETC. please go to the clinic to get tested as soon as symptoms are present, if the close contact is with a person in the same household isolation/quarantine will begin when the positive case is first discovered with an additional five (5) days after the positive case receives their PHN letter. Those who have a PHN letter and are in the ninety (90) day period are exempt from quarantine.



- ❖ Individuals should avoid large gatherings and out of home socializing with exemptions of business meetings and learning institution's, that are not already subject to an approved plan. Other indoor events and social gatherings within the building's capacity, the organization holding the event or gatherings should submit and receive an approved mitigation plan from the local city government where the gathering is occurring.
- ❖ Consequences for not following the mandates can result in fines, 1) \$100.00 warning fine with date and time 2) \$250.00 fine with date and time 3) \$500.00 fine with date and time. Anyone who refuses to pay their fine, the fine be put on the head of household's utility bill.
- ❖ **Any individual/resident that is a known and confirmed positive or is a confirmed close contact that chooses to leave his/her home and will not follow our local mandates and complete their isolation days has three choices, 1) quarantine at old city with supervision, 2) leave town on your own expense, 3) arrest by Buckland VPO's who will then consult the Alaska state troopers to be prosecuted as reckless endangerment.**
- ❖ To enter any public places, you must provide a negative test result that isn't over 72 hours old. This will be in effect until 03/31/2022. PHN Letters are exempt from taking a test.
