The Northwest Arctic Borough Assembly met and held a Regular Meeting on January 23, 2016. Assembly President Carl Weisner called the meeting to order at 9:00 A.M. A quorum was present to conduct business. The Assembly took the following actions:

Action taken on the following:

- 1. Ordinance 16-01** *an ordinance of the Northwest Arctic Borough Assembly approving a contract amendment with Bering Straits, and for related purposes.*
passed unanimously
- 2. Resolution 16-07** *a resolution of the Northwest Arctic Borough Assembly designating the Alaska State Legislative Priorities for Fiscal Year 2017.*
passed unanimously
- 3. Resolution 16-08** *a resolution of the Northwest Arctic Borough Assembly approving the purchase of an excavator, accessory parts, training, and shipment for the Community of Kivalina in an amount up to \$224,500.00.*
passed unanimously
- 4. Resolution 16-09** *a resolution of the Northwest Arctic Borough Assembly approving the purchase of a 10 yard Dump Truck, accessory parts, and training for the Community of Kobuk in an amount up to \$45,000.00.*
passed unanimously
- 5. Resolution 16-10** *a resolution of the Northwest Arctic Borough Assembly accepting State Operating Funds in an amount not to exceed \$50,000.00 to construct ice roads and for related purposes.*
passed with 9 yes, 2 abstain
- 6. Resolution 16-11** *a resolution of the Northwest Arctic Borough Assembly to approve a professional services contract with DOWL in an amount not to exceed \$80,000 and for related purposes.*
passed unanimously

7. Resolution 16-12 a resolution of the Northwest Arctic Borough Assembly approving a contract with Lynden Air Cargo for shipment of a dump truck and dozer to Kobuk in an amount up to \$50,000.00.

8. Resolution 16-13 a resolution of the Northwest Arctic Borough Assembly approving a professional services agreement with Bering Straits Development Company for closeout work on alternative energy projects.

passed unanimously
