1. **Joint Resolution 22-01** a Joint Resolution of the City Council of the City of Kotzebue and the Northwest Arctic Borough Assembly supporting the City of Kotzebue's application for the Rebuilding American Infrastructure with Sustainability and Equity ("Raise") Grant in the amount of Nine Million and Thirty-Seven Thousand Dollars (\$9,037,000) as part of the Local and Regional Project Assistance Program within the Infrastructure Investment and Jobs Act ("Bipartisan Infrastructure Law") for Cape Blossom Site Development and to share equally the cost of developing and submitting this grant application in the amount of Twenty-Seven Thousand, Nine Hundred Dollars (\$27,900).
