#### **RESOLUTIONS**

1. <u>Resolution 15-10</u> a resolution of the Northwest Arctic Borough Assembly to approve a transfer of responsibilities agreement between the State of Alaska Department of Transportation and Public Facilities and the Northwest Arctic Borough.

Member Westlake we had a discussion at the work session, suggested picking out a safe route and recommended staying away from Pressure Ridges this year.

President Weisner announced that he has received some contacts from Kiana and Noorvik interested in the Ice Road and its construction. They were optimistic that it could occur as early as prior to the regional tournament.

Judy Hassinger added there is about \$7,000 in the fund balance that is remaining in the Ice Road fund that can go towards that as well.

Member Ramoth added the request of more PSA's prior to the project on the Radio and Arctic Sounder.

Member Schaeffer just joined by Telephone.

Member Sampson motioned, seconded by Member Ballot; motion passed unanimously.

#### **Executive Session**

Regarding PILT negotiation

Member Ramoth motioned, seconded by Member Vern Cleveland; motion passed unanimously.

Back to order at 11:27 A.M.

Member Ramoth motioned, seconded by Member Vern Cleveland; motion passed 10 yes 1 no, to come out of Executive Session.

#### **AUDIENCE COMMENTS**

Sophie May Foster is currently appointed to the Secretary/Treasurer role for the Search and Rescue here in Kotzebue and requested assistance in a building, new equipment. She stated that in discussions with Charlotte Brower that the State gave them \$250,000 to renovate their building up in Barrow. Looking for funding so that the Search and Rescue can better serve this Region. She thanked the Assembly for their time on behalf of the Search and Rescue.

Brenda Erlich expressed concern about the Inupiaq Language and wanted to know what the Borough is doing to preserve the language in the schools.

Benjamin P. Arnold from Noatak discussed the Northwest Arctic Borough receiving funds on behalf of Native Village of Noatak and that they do provide funding for trail staking. Mr. Arnold questioned if the Native Village of Noatak could request by a resolution to request more funds for our community from the Borough. Mr. Arnold also mentioned ANTHC. He stated that they were going to do six houses for water and sewer. He wanted to know which communities are involved in that. He also discussed the high cost of fuel in the villages.

Adrian Davidson, a researcher for the University of Toronto, is in the Region to meet with some people and thanked the assembly and to anyone she met in the community while she was there.

Mark Moore the Planning Director for the Native Village of Noatak discussed an urgent issue with the Power Plant that sits on the edge of the river. Because of the recent seismic activity that they have been having in Noatak its becoming urgent that they relocate the present Power Plant to a location that is away from the river, the existing fuel farm for the power plant is also on the edge of the river and given the seismic activity they have been fortunate. He thanked the Assembly for their time.

## **ASSEMBLY COMMENTS**

Member Ramoth good meeting, safe travels to everybody, the weather is definitely changing. He reminded everybody listening out in radio land travel safe.

Member Hadley stated that the regionals are coming up and wished good luck to all the basketball players going. And to parents, make sure that your kids get up for school and get their good grades so they can travel.

Member Vern Cleveland thanked everyone for a good meeting, wished everyone safe travels.

Member Ballot comments in Inupiaq.

Member Miles Cleveland Taikuu, good meeting, comments in Inupiaq.

Member Greene it's good to attend the meeting in person and hope I can continue.

Member Nelson requested that when members speak in Inupiaq they also translate in English. Member Nelson stated that Regionals are next week wished luck to all the teams participating. Member Nelson thanked the US Department of Energy for coming up to speak to the Assembly about their plans for the future. She thanked Kevin Higgins for talking about the Senate Bill 30 with the marijuana initiative and encouraged the constituents to attend the committee meetings that they held on Monday so that they can be aware of the discussions that they have as an Assembly. She attended a UAF Symposium in Barrow last week and thought it was really beneficial to come to the table with North Slope Borough and also the University of Alaska and ANTHC. The topic was planning for 2014 and healthy communities and sustainability. Suggested preparation in ways of succession planning's that reflect energy decisions or Inupiaq decisions or environment education about food security on our traditional foods and Economic Development.

Member Sampson thanked everyone, good meeting.

Member Westlake thanked Mr. President and the Assembly for being open today in our discussions, very good meeting.

Member Schaeffer thanked Mr. President. Member Schaeffer spent about an hour with Reid Magdanze (staffer for one of the representatives) along with his parents Jim M and Susan G. They talked about general education. They were open to ideas. He stated that we are facing some significate budget issues here in the next few years, and the need to look at opportunities rather than restrictions in terms of delivering necessary services. Part of the discussion included some dialogue with the State Department of Education along with the commissioner, in what form that will take, he was not sure yet. But it can be about what we can do differently with education to respond to not only to the subject issue, but the quality of education in general.

Youth Representative Chloe Naylor stated that she was happy to be there, she continues to learn more about the Borough activities and also went to Barrow. She stated that our youth need to continue to participate in future activity planning's too.

She thanked everyone for having her there; also she expressed hope that the Assembly will continue to work on our evacuation road because in the fall time it gets so bad and they don't know where to go sometimes, please remember that and pray for us, our village. Taikuu.

#### MAYOR'S COMMENTS

Mayor Joule provided the Assembly some updates on what is going on in Juneau and how the dynamics of what's being considered to make up or how to address the low price of fuel is entering every discussion and it gave the Assembly an update on some of the things, the Teck Center, the School District revenue sharing, community jails, all just a FYI from the lobbyist that is in Juneau. He also brought up for the upper Kobuk and Noatak valleys, the lower Kobuk and also Northern and Interior there is a weather advisory where were expected to get anywhere from 8 to 16 inches of snow in the next two or three days from Wednesday to Friday, it includes Ambler, Shungnak, Kobuk, Red Dog Mine, Kiana, Noatak, Buckland, Deering, pretty much the whole region. He encouraged people to be careful when traveling and to let somebody know where you're going but also be prepared that we may be getting some snow and I just wanted to pass this on as people make travel plans and just to be really safe.

#### **ADJOURNMENT**

President Weisner moved to adjourn; with no other business to conduct, the meeting adjourned at 11:55 A.M.
