The Northwest Arctic Borough Assembly met and held its regular May meeting on May 20, 2025. President Hadley called the meeting to order at 9:00 A.M. A quorum was present to conduct business. The Assembly took the following actions:

Action taken for enactment of ordinances:

1. **Ordinance 25-04** *an ordinance of the Northwest Arctic Borough Assembly providing for the establishment and adoption of the line-item budget for fiscal year 2026.*
(passed by majority)
2. **Ordinance 25-05** *an ordinance of the Northwest Arctic Borough Assembly providing for establishing and adoption of the line-item budget for the FY26 Village Improvement Fund.*
(passed unanimously)

Action taken for introduction of ordinances:

1. **Ordinance 25-06** *an ordinance of the Northwest Arctic Borough Assembly amending the Borough to set guidelines for the unassigned fund balance, and for related purposes.*
(passed unanimously)

Action taken for resolutions:

1. **Resolution 25-16** *a resolution of the Northwest Arctic Borough Assembly approving amendment of a professional services agreement with Deerstone Consulting LLC to provide administration and technical services for the Borough Energy Projects, and for related purposes.*
(passed unanimously)
2. **Resolution 25-17** *a resolution of the Northwest Arctic Borough Assembly approving amendment of the Borough engagement with Altman Rogers to provide FY24 Audit Services, and for related purposes.*
(passed unanimously)
3. **Resolution 25-18** *a resolution of the Northwest Arctic Borough Assembly approving amendment of the Borough's FY25 professional services agreement with Espelin & Associates.*
(passed unanimously)
4. **Resolution 25-19** *a resolution of the Northwest Arctic Borough Assembly approving a short-term lease with ANTHC for summer housing in Ambler, and related purposes.*
(passed by majority)
5. **Resolution 25-20** *a resolution of the Northwest Arctic Borough Assembly providing for a supplemental FY26 local contribution to education.*
(passed by majority)
