### **RESOLUTIONS**

1. **Resolution 15-27** *a resolution of the Northwest Arctic Borough Assembly authorizing a professional services agreement with Accurate Accounting Solutions LLC to serve as the Borough Treasurer and for related purposes.*

4. **Resolution 15-30** a resolution of the Northwest Arctic Borough Assembly authorizing a professional services agreement with McClintock Land Associates for consulting, mapping, and surveying services related to the Borough's Municipal Land Entitlement, and for related purposes.

Fred Smith and Bill McClintock provided a summary of the project; funding has gone up and down. Currently forty-four percent of Borough lands have been conveyed, will eventually get done. Member Westlake verified if there is a specific place they will be this year; which they are unsure of, awaiting for BLM and State DNR surveys.

5. **Resolution 15-31** a resolution of the Northwest Arctic Borough Assembly authorizing a professional services agreement with Drake Construction for heavy equipment maintenance and repair, and for related purposes.

Wendie Schaeffer provided a summary of Resolution 15-31; Member Ballot verified if it is all the villages for maintenance and repair, also buy parts for that right? He mentioned that he had been approached by residents of Borough in regards to the dozer that went through the ice a couple years ago. He heard that someone had taken it from the dump and fixed it up. Wendie mentioned she will follow up.

Member Vern Cleveland mentioned some of the equipment in the villages are antique, some equipment still running since 1977; have to upgrade equipment to today. Otherwise we trade with villages to villages for parts; good luck to the guys.

President Westlake raised his concern regarding the dozer that went through the ice; is there a period where go for salvage for the equipment? Member Vern Cleveland believed that if anything goes under water anywhere, anytime than salvageable; just like an airplane. If they go down, who gonna own airplane if it go down? Wendie will follow up on this matter.
