The Northwest Arctic Borough Assembly met and held a Regular Meeting on July 26, 2016. Assembly President Carl Weisner called the meeting to order at 9:03 A.M. A quorum was present to conduct business. The Assembly took the following actions:

Action taken for first reading:

1. **Ordinance 16-05** *an ordinance of the Northwest Arctic Borough Assembly approving a three-year participation agreement with Alaska Municipal League – Joint Insurance Association, and for related purposes.*

1. **Resolution 16-27** *a resolution of the Northwest Arctic Borough Assembly declaring Assembly Seat E vacant and directing the Borough Clerk to solicit nominations to fill the vacant seat at the Regular 2016 Election.*
