CANDIDATE NOMINATIONS: Please contact the Borough Clerk for nominating petitions. Petitions will be accepted between Monday, June 7, 2021, until Friday, August 20, 2021.

VOTER QUALIFICATIONS: "Voter" means a United States citizen who is qualified to vote in state elections and has been a resident of the Borough for at least 30 days preceding the election and is registered to vote in state elections and is not otherwise disqualified.

Campaigning is prohibited within 200 feet of any entrance to the polling place. (AS 15.15.170)
