**A RESOLUTION OF THE NORTHWEST ARCTIC BOROUGH
ASSEMBLY APPROVING A VILLAGE IMPROVEMENT FUND
APPLICATION FROM THE NORTHWEST ARCTIC BOROUGH
SCHOOL DISTRICT FOR ITS PRE-KINDERGARTEN PROGRAM,
AND FOR RELATED PURPOSES.**

WHEREAS: under Section 11.08.010 of the Borough Code, the Borough Village Improvement Commission was established to identify village service and capital improvement needs, plan and implement capital improvement and public service programs, and oversee investment of the Borough's Village Improvement Fund (VIF); and

WHEREAS: under Section 11.08.020 of the Borough Code, the Commission is responsible for advising the Borough Administration with respect to working with village residents, Borough communities, and village utilities to identify projects and programs for recommended funding; and

WHEREAS: upon recommendation of the Village Improvement Commission, the Assembly and Administration wish to consider the applications recommended for final approval; and

WHEREAS: the Northwest Arctic Borough School District (NWABSD) submitted a VIF application in the amount of \$1,282,116.69 to help fund its Pre-K program for students ages 4-5 at all schools for FY20 and FY21; and

WHEREAS: the Pre-K program will serve an estimated 150 students and employ 11 full-time employees; and

WHEREAS: on February 4, 2020, the Village Improvement Commission passed Commission Resolution 20-07, approving and recommending NWABSD's VIF application for final approval by the Northwest Arctic Borough Assembly and the Borough Administration to fund its Pre-K program for FY20 and FY21 only for the remainder of FY20 in a one-time amount of \$137,233; and

WHEREAS: the program will help promote and foster early learning for all 11 school sites and meets the VIF eligibility requirements while benefitting the region as a whole.

**NOW THEREFORE BE IT RESOLVED BY THE NORTHWEST
ARCTIC BOROUGH ASSEMBLY:** the Northwest Arctic Borough School District's

VIF application to fund its Pre-K program for FY20 and FY21 is approved only for the remainder of FY20 in a one-time amount of \$137,233.
