**A RESOLUTION OF THE NORTHWEST
ARCTIC BOROUGH ASSEMBLY ACCEPTING
ASSEMBLY MEMBER ELIA NAY'S RESIGNATION
OF ASSEMBLY SEAT J, AND FOR RELATED
PURPOSES.**

WHEREAS: Elia Nay submitted her resignation from the Northwest Arctic Borough Assembly to be effective on June 30, 2021 because she will be relocating to Wasilla; and

WHEREAS: Borough Charter § 2.05(E) mandates that an Assembly seat shall be vacated upon the Assembly's acceptance of a resignation; and

WHEREAS: the Borough Assembly wishes to accept Member Nay's resignation; and

WHEREAS: given that Seat J's three-year term expires in October 2021 and is up for election, the Borough Assembly finds good cause to fill Member Nay's vacant seat through the election process at the October 5, 2021 general election pursuant to Section 2.04.050 of the Borough Code.

NOW THEREFORE BE IT RESOLVED:

- 1. Elia Nay's resignation of Assembly Seat J shall be effective on June 30, 2021.**
- 2. The Borough will fill vacated Assembly Seat J at the Borough's general election on October 5, 2021.**

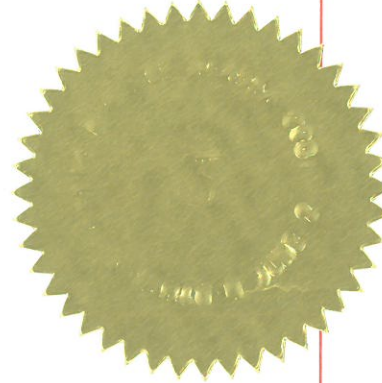
