

**NORTHWEST ARCTIC BOROUGH  
RESOLUTION 20-92**

**A RESOLUTION OF THE NORTHWEST  
ARCTIC BOROUGH ASSEMBLY RATIFYING  
AND APPROVING CARES ACT  
EXPENDITURES, AND FOR RELATED  
PURPOSES.**

**WHEREAS:** under Northwest Arctic Borough Assembly Resolution 20-27, the Borough accepted a total of \$4,077,540 in Coronavirus Aid, Relief, and Economic Security (CARES) Act funds for use in direct response to the COVID-19 public health emergency; and

**WHEREAS:** the Borough Assembly approved use of these funds under Resolutions 20-61, 20-68, and 20-78, and wishes to confirm approval and ratify remaining expenditures as identified in Exhibit A to this Resolution; and

**WHEREAS:** the Borough Assembly extended the Borough's Declaration of Disaster Emergency Proclamation under Resolution 20-84 through April 30, 2021 unless otherwise terminated or modified; and

**WHEREAS:** the continued threat of COVID-19 in the Borough significantly affects health, safety, and security of Borough residents; and

**WHEREAS:** recognizing the continued threat of COVID-19 in the Borough, the Assembly wishes to ratify and approve its CARES Act expenditures in order to provide ongoing assistance to Borough residents in direct response to the COVID-19 pandemic; and


**WHEREAS:** these expenditures are necessarily incurred due to the public health emergency with respect to the COVID-19 pandemic; and

**WHEREAS:** these expenditures were not otherwise accounted for in the Borough's FY20 or FY21 budget; and


**WHEREAS:** these expenditures will be incurred from March 1, 2020 to December 30, 2020.

**NOW THEREFORE BE IT RESOLVED:** that the Northwest Arctic Borough Assembly approves the CARES Act expenditures as identified in Exhibit A to this Resolution.
